Each renewal term will be the same as the original one. On the maturity date, the dividend rate you receive will be the same as those rates the Credit Union offers on new term share certificates on date of maturity.

Telephone Consumer Protection Act

Due to the Telephone Consumer Protection Act (TCPA) that was passed by Congress, all financial institutions are required to obtain consent before calling members on their mobile phones for the purpose of advertising or telemarketing calls and text messages.

At this time Dawson Co-op Credit Union does not utilize an automatic telephone dialing system for this purpose, however, as part of our security system that helps to protect your debit and/or credit card, calls may be placed to your mobile number on file at the credit union. DCCU card processors constantly monitor for potential fraudulent activity on one of your cards, whether a debit or credit card. This is one exemption to the consumer consent requirement.

Other exemptions for pro-consumer purposes include:

- Transactions and events that suggest a risk of fraud or identity theft,
- Possible breaches of the security of member's personal information,
- Steps members can take to prevent or remedy harm caused by data security breaches, and
- Actions needed to arrange for receipt of pending money transfers.

Dawson Co-op Credit Union gives you the option of not allowing automatically dialed phone calls or text messages (we may still call you directly if we need to speak with you).
