



FEE SCHEDULE

Effective: July 20, 2016

TRANSACTION LIMITATIONS FOR ALL SAVINGS ACCOUNTS:

Regulation D requires that during any calendar month you may not make more than six withdrawals or transfers from your savings account to another account of yours or to a third party by means of preauthorized or automatic transfer or telephone order or instruction. Transactions governed by Regulation D include, but are not limited to: automatic transfers from savings to checking for overdraft protection, automatic transfers from savings to any other account, telephone transfers from savings to any other account, preauthorized payments from savings, transfers from savings to any other account using Online Banking. Regulation D allows unlimited transfers or withdrawals from a saving account when made by mail, messenger, ATM, or in person, or when such withdrawals are made by telephone provided a check is mailed to the member. Transfers to repay loans at the credit union and to pay safe deposit box rent are also unlimited.

The categories of transactions for which an overdraft fee may be imposed are those by any of the following means: share draft, in-person withdrawal, ATM withdrawal or other electronic means
